I hope you are staying safe and healthy this summer. The Division of Enrollment Management requested that UHCL extend the test optional policy for incoming freshmen through fall 2021. This policy was approved back in March for fall 2020. The proposed policy (attached) has been reviewed and voted upon by Faculty Senate (24 in favor, 1 opposed). The Deans unanimously supported the extension at their July 15, 2020 meeting.

In order to follow the same process that was used back in March I am requesting that Academic Council review and approve the extension. Understanding that AC does not meet over the summer I propose that committee members review and submit their vote to approve or oppose the extension directly to Charise.
