Old Business – Information Items

I. Accessible Parking in Lot D

- There is a total of 2062 spaces in Lot D.
 - A total of 61 spaces are marked as "accessible."
- The <u>ADA has a formula</u> to determine the minimum number of accessible spaces for a parking lot. For Lot D, we must have, "20, plus 1 for each 100, or fraction thereof, over 1000."
 - Subtracting 1000 from 2062, means we have 1062 spaces left over.
 - Dividing 1062 by 100, and rounding up, suggests UHCL needs 11 more accessible spaces beyond the 20.
 - Therefore, 20 + 11 = 31 accessible spaces. Since 31 > 61, UHCL is in compliance for Lot D.
- Thanks to Doug Wells for pointing out and correcting my error.

II. Van Accessible Parking in Lot D

- ADA states, "At least one of every six [accessible] spaces must be van accessible."
- We have 31 accessible spaces, and 12 van accessible spaces in Lot D. Therefore, we are in compliance by any interpretation of ADA guidelines.

III. Accessible Parking for Visitors

- At the April parking meeting, the parking department said they will make updates to the website to increase awareness about where disabled visitors may park on campus.
 - Status Update
- At the April FSSC meeting, some committee members expressed concerns about the "disabled visitor" plan. Specifically, those committee members were surprised that visitors with a valid accessible parking tag would be required to pay for parking.
 - Doug Wells will discuss.

Texas Transportation Code

Sec. 681.006. PARKING PRIVILEGES: PERSONS WITH DISABILITIES.

- (a) Subject to Section 681.009(e), a vehicle may be parked for an unlimited period in a parking space or area that is designated specifically for persons with physical disabilities if:
 - (1) the vehicle is being operated by or for the transportation of a person with a disability; and
 - (2) there are:
 - (A) displayed on the vehicle special license plates issued under Section 504.201; or
 - (B) placed on the rearview mirror of the vehicle's front windshield a disabled parking placard.

- (b) The owner of a vehicle is exempt from the payment of a fee or penalty imposed by a governmental unit for parking at a meter if:
 - (1) the vehicle is being operated by or for the transportation of a person with a disability; and
 - (2) there are:
 - (A) displayed on the vehicle special license plates issued under Section 504.201; or
 - (B) placed on the rearview mirror of the vehicle's front windshield a disabled parking placard.
- (c) The exemption provided by Subsection (b) or (e) does not apply to a fee or penalty:
 - (1) imposed by a branch of the United States government; or
 - (2) imposed by a governmental unit for parking at a meter, in a parking garage or lot, or in a space located within the boundaries of a municipal airport.

- (d) This section does not permit a vehicle to be parked at a time when or a place where parking is prohibited.
- (e) A governmental unit may provide by ordinance or order that the exemption provided by Subsection (b) also applies to payment of a fee or penalty imposed by the governmental unit for parking in a parking garage or lot or in a space with a limitation on the length of time for parking.






New Business – Information Items

I. Shuttle Bus Location System



- A proposal has been submitted for UHCL to adopt a new Shuttle bus location tracking system.
- The purpose is so that users could know where shuttle busses are (this could decrease user wait time).

Shuttle Bus Location System



- The cost is **\$0** for hardware.
- For service, Verizon Connect would charge \$87.24 monthly for a total of 5 trackers. This is \$17.45 per vehicle per month.
- Implementation would take approximately one month from approval.
- Mr. Doug Wells may have more information to share.
