#### 4. New Business/Announcements

STEM 2 Building - Mark Denney

A discussion was held by Mark Denney discussing the current plan to build a STEM II building. The original plan for the existing STEM building, built in 2018 was for a larger building that could accommodate Biology as well as the other disciplines currently in the STEM building, but the budget did not allow so the building was reduced in size.

The current planning would allow Biology, Computer Science and Computer Engineering to all move from Bayou and Delta to the new STEM II building.

The funding would come from the State using their Covid19 Stimulus funding in lieu of issuing Tuition Revenue Bonds. This would enable the State to essentially pay cash vs. issuing long term debt. The challenge to the current projection is that only Universitie's top projects would be funded – this would leave out funding requested by UHCL to renovate vacated space in Bayou, Delta, and SSCB, critical to enabling the University to reuse that space vacated, should a STEM II building be actually built.

At present, there is no approval for this funding proposal, it is just pending. However, in order to be prepared, the University is embarking on a programming exercise to determine what functions and objectives the building would serve for the campus, and what would be in the building. These are critical planning steps that will be necessary for an eventual architectural firm to take these planning documents and actually design a building to achieve those needs, than a construction firm can then bid on and construct, once funding is actually available.

This work has been ongoing for approximately three months and has engaged faculty from across many disciplines within the College of Science and Engineering, the Dean, Academic Affairs, and Facilities.

The projected location of the STEM II building if approved would be per the current master plan located at the northern most portion of parking lot B, creating the initial portion of the projected green space that would become the central focus of the campus.

#### Master Plan Review – Mark Denney

Vice President Denney gave a discussion on the Master Plan. The issue is that the plan was completed in 2017. Normally, a master plan will be the guide to all planned campus growth, new construction, and improvements. As UHCL is now at the 5-year point, it is a good time to discuss the Master Plan and the assumptions inherent in it.

The plan is to bring up different elements of the Master Plan each month and get feedback and discussion to see how those assumptions, either their accuracy or their inaccuracy could influence future decisions until a new Master Plan is developed for our Campus.

Space Allocation and Utilization Sub-Committee Report – Brian Stephens

Mark Denney gave an update of the committee meeting. They heard one proposal that was informational only from the College of Business needing to modify space to accommodate academic advising now that the advising center has been decentralized out to the colleges. This is a similar, though less expensive proposal as was submitted for HSH in the prior year. The work will be scheduled and completed this year by FMC. A copy of the proposal is attached.

General Description of space request:
